Disaster Management & Recovery LB505 – Preferred Supplier Arrangement (PSA) Overview

This Arrangement provides councils across Queensland and the Northern Territory, as well as other eligible buyers, with streamlined access to specialist disaster management and recovery services throughout all phases of a natural disaster.

Purpose and Scope

The Local Buy Disaster Management & Recovery Arrangement is designed to:

- Provide access to pre-qualified suppliers for time-critical needs.
- Ensure compliance with the Local Government Act and the Local Government Regulation.
- Support alignment with Queensland Reconstruction Authority (QRA) and Disaster Recovery Funding Arrangements (DRFA) requirements.
- Enable councils and other buyers to engage suppliers through a compliant, transparent, and probity-assured pathway.



Alignment with Disaster Funding Frameworks

Queensland Buyers

This Arrangement is structured to align with the QRA, Disaster Recovery Funding Arrangements (DRFA), and State Disaster Relief Arrangements (SDRA) requirements.

Activities delivered under this Arrangement help ensure:

- Compliance with key procurement principles: value for money, probity, and transparency.
- Maintenance of full audit records - including procurement process, contract documentation, and supplier performance - when suppliers are engaged via VendorPanel.
- Clear linkage between works delivered and eligible DRFA project scopes.

Northern Territory Buyers

Reference to QRA and DRFA do not apply to Northern Territory councils.

Buyers should ensure compliance with Northern Territory Disaster Recovery Funding Arrangements and relevant local procurement directives.

Term of Contract

The initial term of this Arrangement is three (3) years, expiring November 2028. Local Buy may exercise up to four (4) extension options, each for a period of up to three (3) years, at its discretion.

Service Categories

This Disaster Management & Recovery Arrangement LB505 includes five (5) service categories designed to support the co-ordination and management of disaster recovery activities across the plan, prepare, response, and recovery phases:

Category 1

Coordination of Counter Disaster Operations.

Category 2

Coordination of Emergency Works and Emergency Response.

Category 3

Disaster Management Consultancy.

Category 4

Disaster Management Program Management.

Category 5

Disaster Recovery-related Grant Writing.

Please note: For the purposes of this Arrangement, *co-ordination and management* do not include the direct delivery of disaster recovery works (e.g. tree lopping or bridge repairs). These services can be procured through other relevant Local Buy Arrangements, as detailed in this toolkit.

If your Local Government Area has been impacted by a natural disaster, and requires goods and services not covered by Disaster Management & Recovery Arrangement LB505, other Local Buy Arrangements are available to support your requirements.

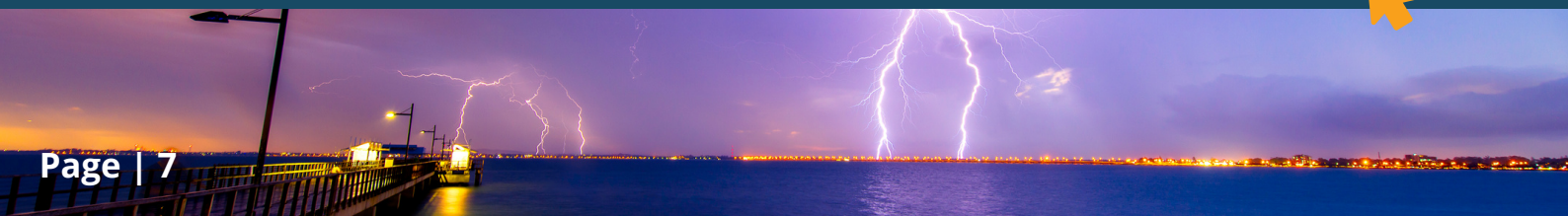

Engaging Suppliers and Special Conditions for Disaster Recovery

Local Buy pre-qualified supplier Arrangements offer a legislatively compliant and efficient procurement pathway for councils to engage suppliers. Use the checklist below to activate support and remain QRA/DRFA-ready:

Step 1: Identify required goods or services

- Determine the category of support needed (e.g. civil works, plant hire, waste management, temporary facilities).
- Refer to the Local Buy Arrangements Matrix as provided with this toolkit or visit localbuy.net.au/Arrangements/Find-an-Arrangement.

Step 2: Choose your engagement method

Option A: Quotation via "VendorPanel"

- Log into VendorPanel. If you don't have a login, please contact us.
- Select the appropriate Local Buy Arrangement.
- Invite one or more pre-qualified suppliers to quote.
- Evaluate responses and award directly in VendorPanel.
- Where required, follow Option B to engage via purchase order.

Option B: Direct engagement via purchase order

- Select a supplier listed under the relevant Local Buy Arrangement.
- Raise a Purchase Order. Ensure items are eligible for disaster funding terms, where applicable.
- Include the Local Buy Arrangement number (e.g. LB505, LB304) on the purchase order.
- Ensure the supplier references the Local Buy Arrangement number (e.g. LB505, LB304) on their invoice and contract documentation.

Step 3: Administer Conditions of Contract and Disaster Recovery Special Conditions

- Local Buy Arrangements have pre-agreed contract conditions with Local Buy suppliers. Councils can use these established conditions of contract to streamline their procurement.
- Local Buy's Disaster Recovery Special Conditions can be applied to any Local Buy Arrangement. Councils may tailor and incorporate these Special Conditions (available in VendorPanel via LB505) into contract conditions with Local Buy Suppliers to ensure alignment with grant funding requirements.
- Refer to the QRA [Queensland Disaster Funding Guidelines](#) to ensure the contracts conditions meet evidence and reporting obligations.

Building resilience through smarter recovery, stronger procurement, and community-focused outcomes.

Natural disasters pose profound economic and social challenges for local councils across Queensland - disrupting infrastructure, services, and community well-being. For Queensland councils, the toll of such events extends beyond immediate damage, impacting council finances, service delivery, and local economies.

Councils often carry significant costs following natural disasters, from emergency operations, clean-ups, and temporary infrastructure repairs to long-term reconstruction of roads, bridges, drainage, and public buildings.

The Queensland Reconstruction Authority (QRA) 2024-25 Annual Report reveals that 73 of Queensland's 77 local government areas (LGAs) were activated under the disaster relief funding scheme (DRFA) during that year, driving reconstruction costs above \$2.2 billion. In the 2023-24 season, 66 of 77 LGAs were affected across 13 extreme weather events, reinforcing the widespread fiscal impact on council jurisdictions.

For local councils, these major cost exposures can strain operating budgets, affect future investment plans, and increase reliance on state or federal assistance. They may also encounter delayed revenue (e.g. for local business rates and tourism-linked income) and unexpected expenditure on recovery-related contracts and materials.

Natural disasters frequently damage council infrastructure with roads, stormwater networks, community facilities, and emergency services access impacted. For example, in the 2023-24 disaster season, over 15,740 km of state-controlled roads were closed or restricted, while almost 250,000 homes lost power across Queensland. For councils, these disruptions demand urgent action, rerouting traffic, repairing assets, liaising with utilities, and managing community expectations.

Moreover, social infrastructure such as libraries, childcare centres and recreational facilities are often closed or degraded, impacting community life and requiring reallocation of council resources. The broader consequence is that councils must balance recovery tasks alongside normal operational responsibilities without diminishing service quality.





Councils also play a crucial role in supporting their communities post-disaster. Psychosocial stress, displacement, and business interruption become acute. In the 2022 South East Queensland rainfall and flooding event, the total social and economic impact was estimated at \$7.7 billion. Councils must step into the frontline of community recovery - operating shelters, coordinating mental-health responses, managing evacuations, and restoring social cohesion.

Council staff, volunteer networks, and local services may face burnout or shortages during extended recovery phases. This heightens pressure on local government to maintain governance, engage stakeholders, and ensure transparent use of recovery funds while community expectations for rebuilding rapidly remain high.

Recovery demands quickly strain supply chains and procurement frameworks managed by councils. The surge in contract activity for civil works, materials, and services after disasters means councils must act fast but also maintain probity, value for money, and fairness. The QRA emphasises locally-led, regionally-coordinated models, requiring councils to engage local suppliers in order to support local economic recovery. Councils must therefore integrate recovery procurement with regular supply chain processes and manage variations, scope creep, and risk in contracts while under pressure.

Natural disasters place a multi-dimensional burden on Queensland local councils:

- **Economic:** Significant costs arise from infrastructure repairs and lost revenue.
- **Operational:** Disruptions to essential services and infrastructure hinder day-to-day functioning.
- **Social:** Councils play a critical role in supporting and rebuilding affected communities.
- **Contractual:** Recovery efforts often require complex and urgent procurement processes.

As disasters become more frequent and severe, councils must build resilience through strategic planning, robust procurement frameworks, strong stakeholder engagement, and proactive risk mitigation, ensuring they can deliver recovery effectively, responsibly and sustainably.



Local Buy Arrangement Matrix v1.0
